

DUFF-O CONTEST RULES

1. **No Purchase Necessary.**
2. One contest winner per household may win one prize valued 100 dollars or greater per 60 days from WDEF, WDOD or WUUQ.
3. One contest winner per household may win one prize valued 99 dollars or less per 60 days from WDEF, WDOD or WUUQ.
4. By participating in the contest, the winner consents to the use, without additional compensation, of his or her name and/or likeness and/or voice for promotion and/or advertising purposes in connection with this contest, WDOD and its sponsors.
5. To win contestants must listen between June 29, 2026 to July 10, 2026 between the hours of 10 am and 7 pm EST. Contestants must listen for the cue to call and be the ninth caller through at 423-642-9636 in order to win a spot for themselves and a guest for our Duff-O party on July 11, 2026.
6. As participants of the Duff-O Bino Party, you and a guest will be given one Bingo board a piece to play.
7. To win a game of Bingo (Duff-O), contestants must meet the requirements of the game set forth by Hits 96 at the event. Should a contestant meet said requirements, they must be the first to stand up and say "Duff-O" in order to win. Judges will determine the winner if there is a tie. All decisions are final.
8. In the event a contestant wins a game of Duff-O and wins a pair of tickets to Hillary Duff in Nashville, they can no longer continue to play.
9. There will be five games of Duff-O where contestants can win tickets to Hillary Duff on July 29, 2026.. The final games prize will be tickets to the show in Nashville on July 30, 2026, one night hotel accommodations and two sound check party passes.
